Feedback analysis on curriculum – 2018-19

The feedback is obtained from all the stakeholders including the students, parents, teachers, alumni and employer to improve the quality of curriculum and teaching learning environment better at the end of each academic year. The feedback is obtained in a structured manner through proformas designed by the IQAC of the college for this purpose. The data collected is consolidated, analyzed and kept confidential and used for the purpose of improving the quality of the institution. After assessment, the IQAC shares the analysis and suggestions made by all the stakeholders with the principal and Heads of the Department through meeting to be implemented.

An analysis of total of 48 responses obtained from the teachers on a five-point scale as shown in the tabular form above. The obtained feedback indicates that the good percentage of responses strongly agree, that the aims and objectives are well defined and has a great scope for prospects in higher education and employability. However, they demanded industrial training, internships and flexibility in the curriculum to include a part of syllabus for the competitive exams.

Feedback from parents were received by their respective departments through Parent Teachers meetings. In these meetings, parents were informed about the academic performance of their ward. An analysis of total 102 responses were given in the above tabular form. As it is evident from the responses above, the parents appreciated that the curriculum content and objectives are well defined and suits the need of learners at all levels. Parents were satisfied with the overall development of the students.

Feedback was also obtained from employer on the curriculum. The responses were obtained through a structured proforma, designed by the IQAC. A total of 4 responses were received and analyzed, as one can see from the responses, the feedback indicates that the curriculum is well designed with striking, a balance between theory and practical knowledge. Though the employers were highly satisfied, they suggested to offer skill-based training programs and workshops related to entrepreneurship for improving the students' performance.

Feedback analysis report 2019-20

The feedback on the curriculum is collected at the end of the academic year 2019-20 through online mode. Feedbacks regarding the curriculum is obtained from the stakeholders such as Students, teachers, parents, employer and alumni by providing separate questionnaires in google forms as designed by the IQAC of the college.

After the compilation of recorded feedbacks from all the stakeholders, the same is assessed by the IQAC for analysis.

The parent feedback questionnaire is structured with 10 questions related to the curriculum and overall development of the students. About 88% of the parents expressed their satisfaction over the course structure and flexibility in the curriculum to meet the employment needs of industries. 90% of the parents agreed that the curriculum contributed to the overall development of the student.

The flexibility provided in the curriculum for employability and for preparing for the competitive exams were highly appreciated by the alumni and Employer, which helps the students to prepare well for the various national level exams. The flexibility mainly focusses on the skill development. The employer feedback appreciated the efforts made to bridge the gap between the academia and industry by implementing the inputs given by the industrialist.

The major suggestions made by the alumni and teachers were to introduce project work and internships in the course structure and also to incorporate value added courses to improve their skills. 
The major suggestions made by the stake holders includes, to offer skill based training programs, project works/ internships to be included in the course structure and also to reach the MoU's with industries to update the technology.
