**Description:** NVDA (The Non Visual Desktop Access) is open source software, which means the code is accessible to anyone. This enables translators and developers around the world to continually contribute to its expansion and improvement. Screen reader is an assistive software programme which helps the visually impaired or the blind to work with computer. It is free; open-source software. It is installed in the computers at Computer Lab to help the visually challenged students in learning. It is developed by NV Access. Besides general Windows functionality, NVDA works with software such as Microsoft office applications, WordPad, Notepad, Internet Explorer, google chrome, etc. It supports the basic functions of Outlook Express, Microsoft Word, Microsoft

PowerPoint and Microsoft Excel. The free office suites Libre Office and Open Office.org are supported by way of the Java Access Bridge package. NVDA also supports Mozilla Firefox.

**Benefits of NVDA:** It helps the blind and visually impaired people to use computers by converting the text on the screen into speech which is then read aloud using synthesized voice. The information can be presented to the user in speech, braille and via on-screen window. Programming using accessible IDE's (Integrated Development Environment) like Eclipse, Visual Studio etc., Browse the internet, Read PDF and other such text documents, Create text documents, presentations etc. Navigate the Windows OS features, Use other accessible software's like audio/video players.





## **POLICY DOCUMENT FOR DISABLED-FRIENDLY, BARRIER FREE ENVIRONMENT**

The Rights of the Persons with Disabilities Act (RPWD Act), 2016 provides that “The Government shall ensure that the Persons with Disabilities enjoy the right to equality, life with dignity, and respect for his or her own integrity equally with others.” This Act prohibits discrimination against individuals with physical and mental disabilities. Government degree college for women, Ramagiri, Nalgonda is against all kinds of discrimination on any grounds including disability. Our College intend to advance a comprehensive and inclusive teaching and learning environment in which incapacitated students and employees are not treated unfavourably. ### **OBJECTIVES OF THE POLICY: -**

- To create inclusive culture to avoid discrimination and exploitation of disable Students and Staff from all spheres of work and education in the college.
- To ensure implementation of all legislations with respect to persons with disabilities
- To create suitable regulatory mechanism for effective delivery of services to disable Students and Staff of the college.
- To provide accessible education to disable students in the college.
- To ensure full participation of persons with disabilities and to provide them the equal opportunities for development.
- To provide all kind of support in academic and examination related issues.
- To provide guidance and counselling to differently abled students.
- To provide necessary budget allocation to achieve above objectives.

**ACCESSIBILITY POLICY:** The institute should provide various provisions in creating a disabled friendly campus. The institute administration and faculty members should ensure appropriate accommodations for each person with a disability, and be willing to resolve access problems. The campus should be barrier free and accessible for persons with differently able.

**The following principles of accessibility will be observed: -**

- To provide accessible study material to all students with disabilities.
- To ensure the awareness programmes for all the teaching Staff and non-teaching staff regarding the issues of accessibility.
- According to the G.O.Ms.No.339, Education (EC.2) Department, dated:15.12.1999, (Visually Challenged/Impaired, Hearing Impaired, Orthopedically Challenged) 3% of the total number of seats in the 1st year of Degree Courses shall be reserved for the Physically Challenged persons.
- The institute will ensure the representation of all the types of disabilities listed in the rights of persons with disabilities 2016 and as per government regulations from time to time.
