

MEMORANDUM OF UNDERSTANDING (MoU)

TERMS OF MOU:

Termination of MOU: The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Head, Department of Public Administration, SRNK Government Degree College, Banswada, Kamareddy with a written one month notice to the Surpanch and

Panchayat Secretary Gram Panchayart, Borlam Village. in the event of non-compliance.

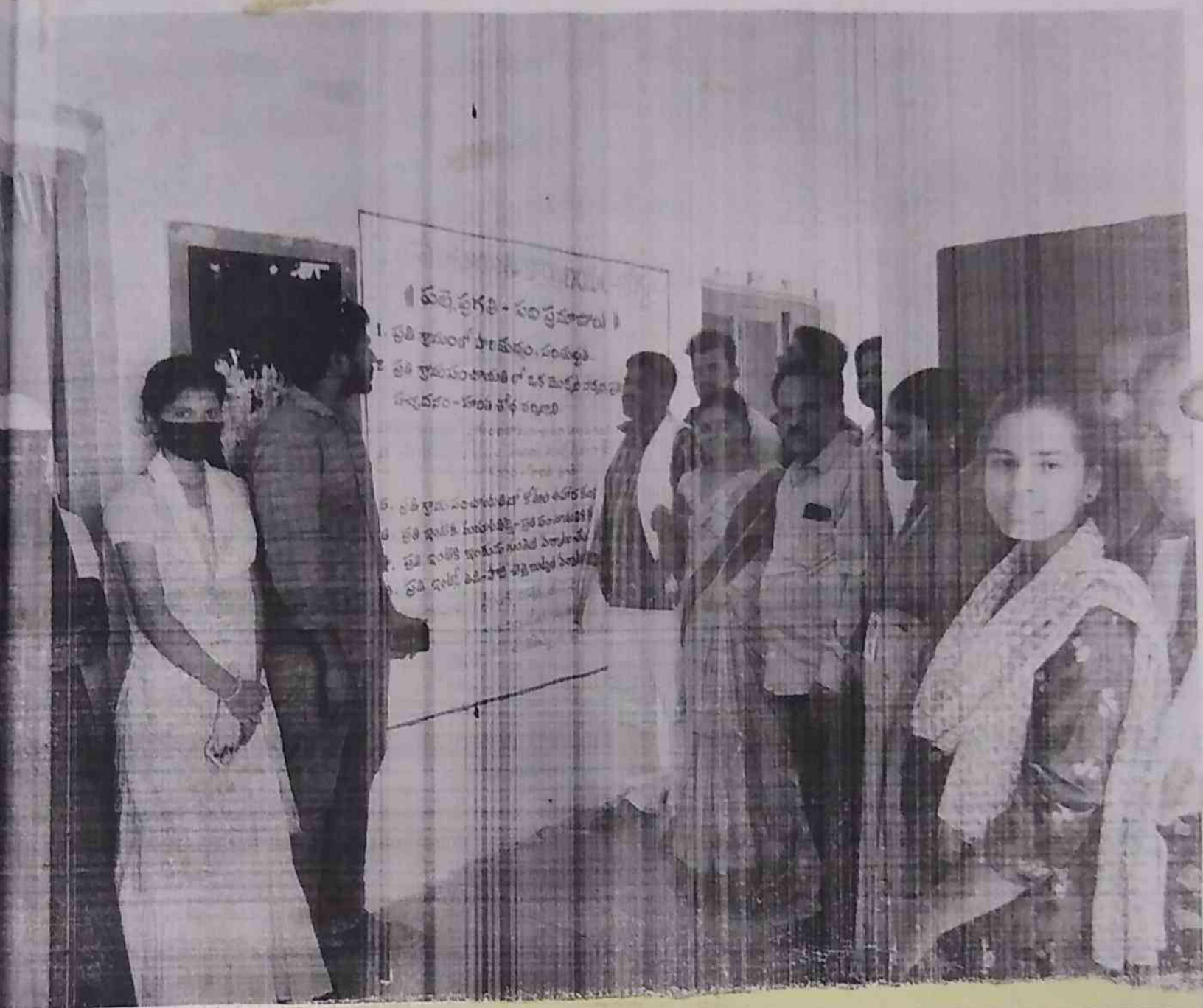
