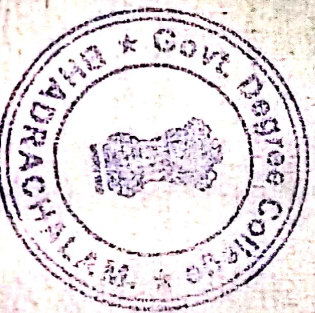

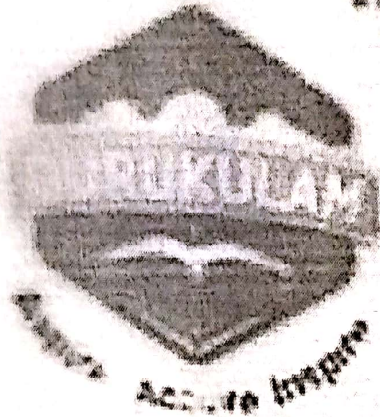

In pursuance of the orders issued in the references 1st to 11th read above and in pursuance of the orders of the Hon'ble High Court Dt. 11-05-2020 in W.P. No. 6745 of 2020 and The Hon'ble High Court, Hyderabad in its order Dt. 25-10-2021 in I.A. No. 1,2,3 & 6 of W.P. No. 45 of 2020 filed by Samala Murali, Khammam District under Rule 10 (a) of Telangana State and Subordinate Service Rules 1996, Sri/Smt. Kurn VUKE RAMADEVI selected through TDT-2017 with Hall Ticket No. 1752115582 is hereby appointed as SA-TELUGU, Govt Management, AGENCY AREA in the scale of pay Rs. 42300-115270 and he/she is posted at GHS BHADRACHALAM, BHADRACHALAM Mandal, erstwhile Khammam District subject to the following conditions:

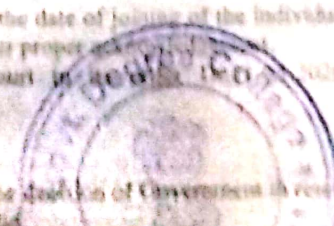
- That his/her appointment is purely adhoc and can be terminated at any time without any notice and without assigning any reasons for such termination.
- If the certificate furnished by the candidate in respect of qualifications, local area, caste, PHC etc., is found to be non-genuine, bogus, the selection/appointment will be cancelled in addition to initiating criminal case against the individual at any time.
- The he/she should join duty within a period of 15 days from the date of receipt of appointment orders, failing which his/her appointment will be cancelled without any further notice.
- The he/she should produce all original certificates issued by the competent authority and physical fitness certificate in the prescribed proforma issued by an authority not below the rank of civil surgeon before the Head Master / Mandal Educational Officer prior to his / her joining duty for verification.
- During verification if any of the certificate submitted by him/her found to be false/bogus, the appointment orders will be withdrawn/cancelled.
- His / her services will be regularized from the date of actual joining in the post as per Telangana State and Subordinate Service Rules 1996.
- His / her services are governed by the New Contributory Pension scheme rules prescribed in GO Ms No 654 Finance Dt: 22-09-2004 and GO Ms No 655 Finance Dt: 22-09-2004 as amended from time to time.
- He / She shall submit an undertaking that he/she shall abide by the conditions stipulated in the appointment order.

- In the reference 9th read above, the Hon'ble High Court in its order Dt. 11-05-2020 in W.P. No. 6745/2020 has made the following order:

ORDER

"In this case, the issue for consideration is whether the selection of Government in respect of all the vacancies as a result of the selection of Government in respect of all the vacancies is valid."

Further, the Hon'ble High Court in its order Dt. 11-05-2020 in W.P. No. 6745/2020, by relying on the recent judgment of the Hon'ble Supreme Court in "Chakrabarti and Ors. Vs. State of A.P. & Ors." in Civil Appeal No. 1309 of 2005.

Accordingly, it is ordered that the selection of the candidate, who is selected by the Government, is valid and the appointment of the candidate is valid.

remaining vacancies by the local tribals, whereas, in view of the judgment of the Hon'ble Supreme Court, referred to above, it is not permissible to fill up the vacancies beyond 50%.

Prima facie, what is contended by learned counsel for the petitioner appears to be valid. Having regard to the same, the respondents are directed not to fill up the remaining vacancies to the post of Secondary Grade Teacher, if already 50% of the vacancies are filled up by the local schedule tribe candidates.

Further, the Hon'ble High Court has issued modified interim orders Dt. 25.10.2021 in I.A.No.1,2,5 & 6 of W.P.No.6745 of 2020 filed by Sri.Samala Murali. Khammam District has made the following orders:

ORDERS

"When the matter is taken up for hearing, Sri.M.Ramgopal Rao, Counsel for impleaded respondents 30 to 39, has contended that the writ petition is filed challenging the Notification No.53 of 2017 dated 21.10.2017 on the ground that in Civil Appeal No.3609 of 2002 (Chebrolu Leela Prasad Rao & Others vs State of A.P. & Others), the Hon'ble Supreme Court rendered a judgement on 22.04.2020, wherein it was held that there cannot be 100% reservation in favour of Scheduled Tribes in the scheduled area. Counsel further contended that the said judgment has no retrospective effect as the said judgement was rendered on 22.04.2020 and the Notification, which is being challenged, was issued on 21.10.2017. Therefore, the interim order passed by this court on 11.05.2020 has to be modified as the said judgment has no relevance when it comes to the notification dated 21.10.2017.

Counsel appearing for the petitioner has also not disputed about the said fact.

In view of the aforesaid submissions, this court is of the considered view that the interim order dated 11.05.2020 needs to be modified and accordingly, the same is modified as under:

"The respondents are directed to fill up the posts in terms of Notification dated : 21.10.2017. However, it is made clear that any appointments made will be subject to the result of the writ petition".

Post the writ petition for hearing on 08.11.2021".

Hence, You are informed that, this appointment is subject to the outcome of the W.P.No. 6745 of 2020 and other pending court cases.



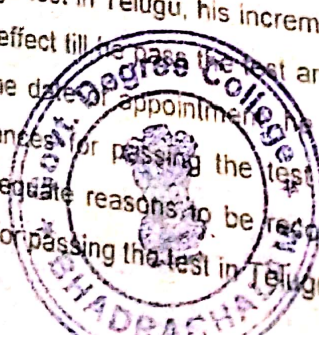

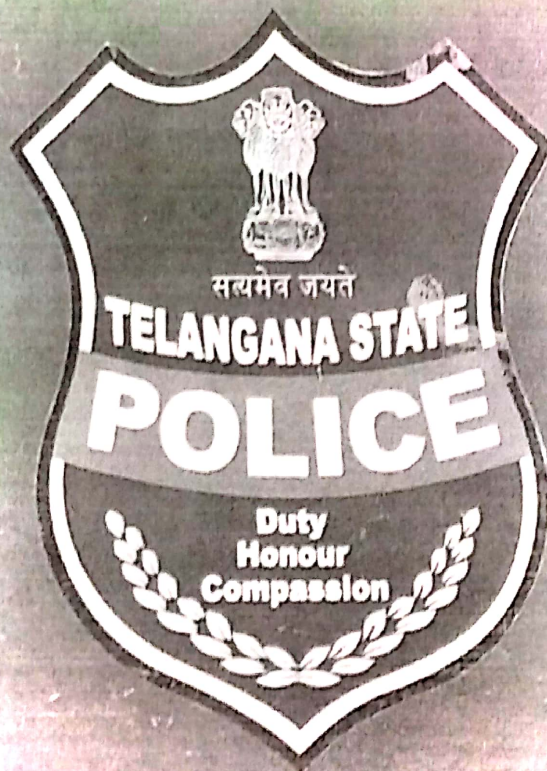

No. 1175174, SCTPC TSSP who has successfully completed his 9 months institutional training, is hereby appointed as PC TSSP w.e.f. 26-07-2021 in the time scale of pay Rs. 24280 - 690 - 24970 - 720 - 27130 - 750 - 29380 - 830 - 31870 - 940 - 34690 - 1030 - 37780 - 1110 - 41110 - 1190 - 44680 - 1280 - 48520 - 1400 - 52720 - 1500 - 57220 - 1630 - 62110 - 1730 - 67300 - 1850 - 72850 in RPS 2020. Subsequently he is posted to 6th Bn TSSP in the existing vacancy with immediate effect. Further, the conditions as per service rules abiding his appointment are mentioned below.

As per rule 16 (c) (i) of TS State and Subordinate Service Rules-1996 he will be under probation for a period of 2 years on duty within a continuous period of 3 years from the date of appointment. He must complete (2) years of duty period within (3) years from 26-07-2021, failing which his services will be terminated. The appointment orders are subject to outcome of WPs/SLPs pending if any. He is informed that as per rule 17 (ii) of TS State and Subordinate Service Rules-1996 the appointing authority may, at any time before or after expiry of the prescribed period of probation either extend by not more than one year, whether on duty or otherwise, the period of probation of a probationer, in case the probation has not been extended under sub-rule (b) of this rule or terminate his probation and discharge him from service after giving him one month's notice or one month's pay in lieu of such notice, on account of unsatisfactory performance or progress during training or unsatisfactory performance of duties or unsatisfactory conduct or for any other sufficient reason to be recorded in writing.

- i) As per rule 16 (e) of TS State and Subordinate Service Rules 1996, the appointees with in the period of probation period should pass requisite tests/examinations. As per rule 16 f (ii) if within the period of probation a candidate fails to pass such tests or acquire such qualifications as may be prescribed in the rules or in the special rules, the appointing authority shall by order discharge him from service unless the period of probation is extended under the sub rule (b) of Rule 17 and if within such extended period also, the candidate fails to pass such tests or acquire such qualifications, the appointing authority shall discharge him from service.
- ii) If his mother tongue is not Telugu or if he has not taken Telugu as second language in 7th or 8th class or any higher examination, he should also get himself qualified by passing the Third language test in Telugu conducted by the TS Public Service Commission within the period of probation prescribed. If he fail to pass the third class language test in Telugu, his increments in the time scale of pay shall be postponed without cumulative effect till he pass the test and if he do not pass the test within a total period of 3 years from the date of appointment, he will be discharged from service, unless he is given additional chances for passing the test by the Director General of Police, TS, Hyderabad who may for adequate reasons, to be recorded in writing give a probationer two successive additional chances for passing the test in Telugu.
