

MEMORANDUM OF UNDERSTANDING (MoU)

(Hereafter known as second party)

This MoU is entered on the 5th day of February, 2021 by and between Jatheeya Sahithya Parishath Siddipet Branch, SIDDIPET

and

Department of Telugu, Government Degree College (A), Siddipet, an Autonomous College that is re-accredited with NAAC "A" grade, affiliated to Osmania University, Hyderabad, offering UG and PG programmes in Telugu.

1. OBJECTIVES OF THE MOU:

- i. To promote and enhance the Creative & communication skills among the UG and PG students of the Telugu department.
- ii. To provide Book publication opportunities to the students
- iii. To promote research and development in Telugu literature activities
- iv. To allow the students to visit Ja.Sa.Pa Organized programmes
- v. To grant permission for Short term training programmes in story writing, poetry writing skill development workshops
- vi. Organize literary competitions for students.
- vii. Extension Lectures for student progression

2. TECHNICAL AREAS OF COLLABORATION:

- i. To provide necessary guidance for the establishment and development of Research, Curriculum etc.
- ii. Provide necessary help in engaging Workshops/ Conferences/ Seminars/ Spot Writing for enhancement of skills of faculty and students.
- iii. To provide training to our students for Telugu DTP.

3. PROPOSED MODES OF COLLABORATION:

Jatheeya Sahithya Parishath Siddipet Branch, Siddipet and Dept. of Telugu, GDC (A), Siddipet proposed to collaborate through the following:

- i. Cooperation and promotion of education and trainings in areas of mutual interest
- ii. A specific plan will be worked out by both of these parties depending upon the availability of resources.

4. TERMS AND CONDITIONS:

- i. Both the parties agree to help, identify and invite the faculty members and researchers from other institutes to participate in conferences, Workshops etc.
- ii. This MoU may be amended, renewed and terminated by mutual written agreement at any time.
- iii. Either of the parties shall have the right to terminate this MoU upon 60 days print written notice to the other party.

5. DURATION OF MOU:

This MoU, unless extended by mutual written consent of both the parties, shall expires in two years after the date specified in the opening paragraph, However, the MoU shall be extended for another one year by mutual consent.

6. COORDINATORS:

Both parties will designate persons who will have responsibility for coordination and implementation of this agreement.




