All the regulatory authorities namely the Registrars of Universities, the Secretary, Board of Intermediate; the Director of Technical Education, the Director, School Education; Secretary, Para Medical Board, the Director, Medical Education, and all the Welfare Officers in the State of Telangana are invited to the references cited, wherein certain instructions have been issued for registration of Colleges and verification of students in e-pass system to enable process the data of students who are admitted under Convener Quota through CETS for sanction of Post Matric Scholarship.

2. The registration of Colleges and Students for the Academic Year 2023-24 in TS e-pass website has commenced from 19<sup>th</sup> August, 2023 and is going to ceased on 31<sup>st</sup> December, 2023.

3. In the reference 6<sup>th</sup> cited, the Commissioner, SCDD, TS, Hyderabad has informed that, the admissions for various Professional/ Degree and Post Graduate courses are not completed so far and the eligible students have to register their applications after completion of admission process in the above courses. The admission process generally continue till the end of January 2024 in professional and other courses. As seen from the ePass website, so far, only (5,08,139) renewal students against (8,04,304) have registered their names in the ePass website. Similarly only (1,82,051) fresh students have registered their names so far in ePass website, as against (5,50,000) approx fresh applications. For the academic year 2023-24 the Govt., have permitted to register the applications up to 31-12-2023. The Conveners of CPGET, DIETCET, INC, KUNR, LAW CET & SW2 have not yet finalized counseling data which requires for fresh registration of students.

4. The Commissioner, SCDD, Hyderabad has therefore requested the Government to extend the last date upto 31.03.2024, so that all the eligible students are registered for the academic year 2023-24. As the last date of registration is on a verge of closure, he has requested the issue necessary orders at an early date.

5. After careful consideration, Government hereby permit to extend the last date from 31.12.2023 to 31.01.2024, for Colleges and Students registrations in epass website for sanction of renewal and fresh scholarships for the academic year 2023-24.

6. All the regulatory authorities and College Managements must ensure that all Colleges & Students who wish to register in e-pass will upload their data upto 31.01.2024, for sanction of renewal and fresh Scholarships for the Academic Year 2023-24.

7. All the students who are contemplate to get the benefit of Scholarships must visit the e-pass website at <http://telanganaepass.cgg.gov.in> and upload their data to register in e pass website for sanction of fresh and renewal Scholarships.


