- 6. The amount of the grant shall be drawn by the Account Officer, SERO, UGC, Hyderabad (Drawing and Disbursing Officer), University Grants Commission on the Grants-in-aid bill and shall be disbursed to and credited to the Principal, SRI RAMACHANDRA GOVT ARTS & SCIENCE COLLEGE LAXNIDEVIPALLY KOTHAGUDEM 507101. by him/her through Cheque /Demand Draft/Mail Transfer.
- 7. The Grant is subject to the Adjustment on the basis of Utilization Certificate in the prescribed Performa submitted by the College.
- The University/College shall maintain proper accounts of the expenditure out the Grants, which shall be utilized, only on approved items of expenditure and ensure proper labeling of the items purchased.
- 9. The utilization certificate to the effect that the Grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as early as possible after the close of the current financial year. Balance grant will be released only on receipt of audited UC and Statement of Expenditure etc., signed by Chartered Accountant.
- 10. The assets acquired wholly or substantially out of University Grants Commission's Grant shall not be disposed or encumbered or utilized for the purposes other than those for which the Grant was give, without proper sanction of the University Grants Commission and should, at any time the College ceased to function, such assets shall revert to the University Grants Commission.

- 11. The University/College/Institute shall maintain a Register of Assets acquired wholly or substantially out of the Grants in the prescribed form.
- 12. The grantee institution shall ensure the Utilization of grants-in -ald for which it is being sanction/paid. In case of non-Utilization/part utilization, or mis-utilization of grants sanctioned by the Commission for the purpose for which these were approved and in accordance with the terms and conditions of the approval or does not furnish the required documents or is disaffiliated from the University the entire amount paid by the Commission shall be refunded by the College with simple interest @ 10% per annum as amended from time to time on unutilized amount from the date of drawl to the date of refund as per provisions contained in General Financial Rules of Government of India will be charged.

13. The grant should not be used for Self-Financing/Unaided Courses.

- 14. It may be noted that the accounts of the grant-in-aid institution shall be subject to inspection by Officers of the SERO, UGC, Hyderabad.
- 15. The interest earned by the University/ College/Institute on this grants in aid shall be treated as additional grant and may be shown in the U.C./Statement of expenditure to be furnished by grantee institution.
- 16. The University/College/Institute shall follow strictly all the instructions issued by the Government of India from time to time with regard to reservation of posts for Scheduled Castes/Scheduled Tribes/OBC/PH/etc.,
- 17. The University/College shall fully implement to Official Language Policy of Union Covt. and comply with the Official Language Act, 1963 and Official Languages (Use for Official purposes of the Union) Rules,
- 18. The sanction issues in exercise of the delegation of powers vide Commission Office Order No: 25/92 dated May 01,1992.
- 19. The funds to the extent are available under the Scheme.

#### MOTIFICATION

Thereas, on account of large scale misappropriation of funds, mis-management and in response to several mass agitation and appeals made by the students, staff and all sections of the society including the M.L.As of the District belonging to 5 political parties, the Government issued orders in Memo.No.79/J2/84-22 Edn., dt.6-5-1985 for baking over Sri Ramachandra Arts & Science College, Kethagudem, Khammam Dist. through a notification under sub-section (6) of Section 60 of the A.P. Education Act, 1982 (Act 1 of 1982), which was published in the Government Gazette dated 6-5-1985. The Government also appointed a Special Officer (Principal, Govt.College) Bhadrachalam) for the purpose of carrying on the Managementof the said institution for and on behalf of the Government.

- 2) And whereas, the Director of Higher Education in his proceedings Rc.No.296/K3-1/83, dt.19-3-85, issued orders suspending the management of the College under Sub-section (3) of Section 24 of of Andhra Pradesh Education Act, 1982;
- a Special officer, the erstwhile Private Hangement of Sri Ramachandra arts & Science College, Khothagudem filed W.P.No. 4892/85. The Hon'ble High Court in their order dated26-6-85 in N.P.M.P.No.6812/85 and J.V.M.F.No.735/85 in N.P.No.4699/35 ordered to maintain status and as on that date. The Management again filed J.A.No.7467/85. The Hon'ble High Court in their order dated 19-1-1991 in A.A.No. 1467/35 in T.P.No.4899/85 have dismissed both the I.A. as well as. Writ Petition, as withdrawn;
  - 4) And whereas, the Hon'ble High Court in its order dtated 12-2-97 in Writ Petition No.7791/39 among other things, has directed to complete the enqurity pursuant to the Memo.No.2597/CZ.3/87-2, Education complete the enqurity pursuant to the Memo.No.2597/CZ.3/87-2, Education dated 7-5-1988 after giving notice and reasonable apportunity to the
