- Abide by the rules and regulations of the institution.
- Abide by the procedures to ensure student's safety.
- Collaborate with fellow teachers.
- Be responsible and interact positively with parents and other stakeholders in educating the students.
- Be good counselors and facilitators.
- Help, guide, encourage and assist students in their learning.

#### **Code of Conduct for Students**

- College timings are from 0900 hrs to 1600 hrs.
- Students should be punctual to their classes. The gates will be closed by 0915 hours.
- Students should wear their Identity Cards in the college premises.
- Visitors are not allowed to meet their wards in the college hours.
- 75% of attendance is compulsory to appear for semester Examinations, Internal Assessment tests and for claiming scholarship.
