Practicals will be conducted in Semester II, if externally put added to average of internal. It is resolved that the Dept of English and the Dept of Communicative English will follow the syllabus, hours allotted and credits allotted in accordance with the pattern approved by English Department, Osmania University for Semester III and IV for 2017-2018 and Semester V, VI for 2018-2019.

The scheme of Evaluation both Internal and External was approved for the ratio 25:75 for General English and Communicative English. The Chairperson, BOS, Prof. T. Vijayakumar observed that the syllabus, Marks allotment, credit allotment and hours allotted correctly conforms with the pattern designed by Dept of English, Osmania University.
