In pursuance of the orders issued in the references read above, the Departmental Promotion Committee has met on 22.11.2010 and approved the names of eligible Junior Lecturers for promotion (Recruitment by transfer) as Lecturers of Government Degree Colleges. Consequently, **Sri/Smt.A. Sambasiva Rao, , Junior Lecturer in Hindi, Government Junior College (B) Mahabubabad, Warangal District** is appointed temporarily on adhoc basis under Rule 10(a) of the A.P. State and Subordinate Service Rules of 1996 as Lecturer in Hindi under APCES in Revised State Pay Scales 2010 and posted to Government Degree College (M) Khammam, Khammam District in the existing vacancy at his/her request, subject to condition that he/she should possess the requisite qualification i.e., NET/SLET or Ph.D as prescribed under Rule-8 read with Annexure of G.O.Ms.No.47, Higher Education (CE.I) Department, dated 14.05.2007 read with G.O.Ms.No.128, Higher Education (CE.I-1) Department, dated 24.08.2010 for the post of Lecturer in Government Degree College, within a period of 5 years, failing which, he/she will stand reverted to his/her feeder category/ post i.e., Junior.

Lecturer, on the expiry of said concession period, or earlier in case of arising of legal eventuality as noted in next para.

Therefore, in continuation of the above para, he/she is further informed that the promotion (recruitment by transfer) as Lecturer of Government Degree College is subject to the out come of the O.As / Writ Petitions pending before the Hon'ble A.P.Administrative Tribunal and Hon'ble High Court of A.P., Hyderabad, related to the issue of eligibility by possessing the educational qualifications prescribed as per UGC Regulations, 2009 followed by Government of A.P. vide reference 9th above which is yet to be finally adjudicated by Hon'ble High Court as per reference 5th above. Therefore depending on the final outcome of said legal issue, the services of the temporarily promoted Junior Lecturer may be liable for reversion if and when such a legal eventuality arises on account of final disposal thereof by the competent Judicial Authority.

The individual is not entitled for any T.T.A., and joining time etc., as his/her posting on promotion is ordered at request.

The Junior Lecturer now promoted is informed that his/her services as Lecturer are purely temporary and liable to be terminated at any time without any notice and without assigning any reason what so ever for such termination. The Government through reference 1st read above has issued guidelines regarding the importance, functioning and appointment of staff in the Autonomous Colleges. The following is mentioned for selection of Lecturers in Autonomous Colleges.

- i) Ph.D./M.Phil. (In order of preference)
- ii) Aptitude innovation and academic excellence.
- iii) Must be drawing UGC Scale of pay. If lecturers are not available or not willing, then lecturers drawing other scales may be posted.
- iv) Must possess a minimum of service of 2 years as lecturer
- v) The tenure may be 5 years at a time.

The Commissioner of Collegiate Education, Telangana State, Hyderabad decided to implement the guidelines as prescribed in the G.O. vide reference 1st read above and issued a notification vide reference 2nd

read above for selection to the post of Lecturers in Autonomous Government Degree Colleges.

The selection committee as prescribed in G.O. 1st read above, has recommended certain Lecturers of Government Degree Colleges to work in Autonomous Government Degree Colleges.
