

MEMORANDUM OF UNDERSTANDING (MOU)
Between
Dr. B.R.R. Government Degree College
And
Government Junior College (Girls) U/M, Jadcherla

This Memorandum of Understanding (herein after referred to as 'MOU') entered on the 06 Day of **August 2019** at Jadcherla by and between: Department of Botany, **Dr. B.R.R. Government Degree College, Jadcherla, MAHABUBNAGAR** accredited with NAAC "B" grade, herein after referred as the first party, **Government Junior College (Girls) U/M, Jadcherla.:** A **Government College** herein after referred to as the Second Party.

The First Party and the Second Party hereby agree as under:

Provision of academic activities to the High school students of Government Junior College (Girls) U/M, Jadcherla.

Objectives:

1. Provision of teaching facilities in needed subjects and topics by the staff of **Dr. B.R.R. Government Degree College**
2. Provision of lab facilities by allowing the students to the labs of Dr. BRR Govt. Degree College.
3. Provision of Observation and explanation of various plants of Telangana Botanical Garden to the students, which provides live study.

TERMS OF MOU:

1. **Duration of MOU:** This MOU shall be effective from the date of signing and shall remain in force for a period of 4 years from the said date.
2. **Termination of MOU:** The partnership covered by this MOU shall terminate on the completion of the stipulated period. The agreement may also be terminated by the Principal, **Dr. B.R.R. Government Degree College** with a written one month notice to the Principal **Government Junior College (Girls), Jadcherla** in the event of non-compliance.

2. **FINANCE: Government Junior College (Girls), Jadcherla** shall not pay any fees associated with the participation of Dr.BRR Government Degree College staff and in the provision of its lab facilities.
3. Both parties assure that this agreement does not go against the rules and regulations of **Dr. BRR GOVERNMENT COLLEGE, JADCHERLA.**(As it is a Government Entity)
4. If this agreement goes against rules & regulations at a later date and when it comes into light, the agreement will stand nullified automatically or will be cancelled immediately by the Principal of **Dr.BRR GOVERNMENT COLLEGE, JADCHERLA** or Principal, **Government Junior College (Girls), Jadcherla**
