2. Provision of facilities by allowing the Microbiology students to Share knowledge with students of **ZP High School (Girls), Badepally.**


**TERMS OF MOU:**

3. **FINANCE:** **ZP High School (Girls), Badepally** shall not pay any fees associated with the participation of **Dr. BRR Government Degree College** staff and in the provision of its lab facilities.

4. Both parties assure that this agreement does not go against the rules and regulations of **Dr. BRR GOVERNMENT COLLEGE, JADCHERLA.**(As it is a Government Entity)
