TERMS OF MOU:


1. Duration of MOU: This MOU shall be effective from the date of signing and shall remain in force for a period of 4 years from the said date.

Termination of MOU: The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Principal, **Dr. B.R.R. Government Degree College** with a written one month notice to the **Anantha Venkataramireddy Seva Samithi, Bhureddipally** in the event of non-compliance.

2. **FINANCE:** Anantha Venkataramireddy Seva Samithi, Bhureddipally shall not pay any fees associated with the participation of Dr.BRR Government Degree College staff and in the provision of its lab facilities.


