ORDER:-

In the G.O. first cited, orders have been issued for the opening of a Degree college at Nirmal, Adilabad District during 1971-72 with B.A., B.Com. and B.Sc., courses. Orders have also been issued in the G.O. first cited for the creation of the post of a Principal, one post of U.D.C. one post of typist and two posts of attenders.

2. The Director of Public Instruction was requested to submit necessary proposals for sanctioning further staff in the said college after admissions are made.

3. The Director of Public Instruction in his letters second cited has submitted proposals for the sanction of further staff in that college during the current year i.e. upto 29-2-1972 as mentioned below.

TEACHING STAFF :-

- (i) Lecturers one each in English, Telugu, History, Economics and Commerce.
- (ii) Asst. Lecturers one each in Urdu, Hindi, Politics, Public Administration, Botany, Zoology, Maths, Physics and Chemistry.
- (iii) Tutors one each in English, Telugu, Commerce and Maths.
- (iv) Demonstrators one each in Physics, Chemistry, Botany and Zoology.

NON-TEACHING STAFF :-

- (i) One Graduate Librarian
- (ii) One Physical Director.

4. The Govt. after careful consideration sanction the creation of the posts referred to in para 3 above in the current year upto the end of 29-2-1972 in the Govt. Degree College at Nirmal, Adilabad District. The incumbents of the posts mentioned in para 3 above will be eligible to draw the usual scales of pay and allowances admissible under the rules in force.

5. The newly sanctioned posts may be filled up according to necessity and with reference to work load and actual need.

6. The Govt. also sanction a non-recurring expenditure Rs.32,622/- (Rupees Thirty two thousand and six hundred and twenty two only) and a non-recurring expenditure of Rs.51,050/- (Rupees Fifty one thousand and fifty only) during the current year i.e. 1971-72.

7. The expenditure shall be debited to "28 Education - A. University - Arts Colleges for Men, Telangana - 7 Opening of New Colleges for general Education during 1971-72.

8. The Director of Public Instruction has requested to provide funds under this new head of account referred to in para 7 above by reappropriati-
