Gummadi Narasaiah, Former MLA of Yellandu and college planning and development committee (CPDC) relentlessly put efforts for the construction of new building in the outskirts of the town. After completion of the building the college was moved to the new building on 23rd January 2003. The college is well equipped with Botany, Zoology, Physics, Chemistry And Computer Labs. TSKC Centre is added advantage to the college. Presently the institution is offering B.A, B.Com and B.Sc Courses with different specializations. The prime motto of the college is **Seelena Shobhote Vidya “Education Glorified with Virtue”** and strives hard to excel in academic excellence, reaching new heights, inculcate human values and scientific temper. The college also accommodates Dr. BR Ambedkar Open University Centre (BRAOU) with faculty members of the college are serving as resource persons.

Government Degree College, Yellandu was established in 1991. This institute has been successfully running with a great outcome since its establishment. Many of this college students passed out are in highly reputed positions, one of them being Dr.Gummadi Anuradha, working as Principal of University Law College, Osmania University, Hyderabad. Since its inception, the college has been affiliated with Kakatiya University, Warangal. The university prepares the yearly or semester Almanacs at the beginning of the academic year. Our institution follows the Almanac and curriculum prescribed by the university for the UG programs. The college offers UG courses such as B.A, B.Com, and B.Sc with different specializations. At the beginning of the academic year, the institutional academic calendar and timetable are prepared collectively by all the teaching staff members and adhere to them.

The principal constitutes various administrative and academic committees for the implementation of action plans regarding curriculum, co-curricular and extra-curricular activities, and the preservation of respective reports and documents in prescribed format for the smooth running of the institution.

The CBCS curriculum is designed by TSCHE (Telangana State Council of Higher Education). The choice-based credit system was introduced from the academic year 2016 -17. The academic plan includes curricular, co-curricular, and extracurricular activities for the effective implementation of the curriculum. All the members of the faculty maintain the records of individual teaching diaries, individual timetable, lesson plan, curricular and co-curricular activities conducted by respective departments. In this regard review meetings are conducted from time to time to monitor the status of the academic activities. such as

Bridge courses are conducted at the beginning of the academic year in all subjects and across the curriculum. CBCS curriculum is given to every lecture to enrich the CBCS syllabus.

The institution celebrates the birth and death anniversary of the great Indian leaders to inculcate the universal values of truth, non-violence, honesty, integrity, and universal brotherhood. We also do things like Haritha haram, swatch Bharat, digging for rainwater harvesting, etc. to help the community. These activities will develop the nexus between humanity and nature. The institution is conducting remedial classes for the slow learners and students' seminars, and study projects (Jignasa) for the advanced learners.

Yuvatharangam is a special platform designed by CCE, Hyderabad, which will give students a wider scope to display their special skills and abilities in sports games or literary and cultural activities.

To improve their curriculum, teachers are encouraged to attend online webinars, training, workshops, conferences, refresher courses, and orientation programs.

Infrastructure like classrooms, seminar halls, TSKC lab, practical laboratories, and computer operating training programmes are added advantages for curricular development. TSKC teaches them how to use computers and how to get a job, so they can compete in the competitive world. 2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Response:

Our college, Government Degree College Yellandu, undertakes the following initiatives to improve the learning levels with the help of faculty members: Students admitted to our college belong to different backgrounds with different academic standards. It is a big challenge for the faculty members to cater to the needs of these students towards employability skills and overall development in their career. As soon as the completion of the admission procedure, the college organisers organised an orientation programme for the students under graduate to be aware of their socio-economic background and to identify their standards of interest, ideas, plans, and intentions were discussed and resolved to pave the way for the right process of offering education to them which is required.

Bridge courses are initiated for all the non-commerce students at the beginning of the academic year that get admissions in B.Com. The faculty members can identify the advanced and slow learners based on their performance in internal and external examinations as well as in classroom interactions.

For the slow learners, doubts are cleared and remedial classes will be conducted with extra coaching where they require support. Additional reading material will be given to increase their understanding of the subject. The bilingual explanation is done in the class so that the slow learners can be brought up to speed with the rest of the class. Academic, personal, and career-related counselling is given from time to time. Home assignments are given and evaluated regularly. Peer learning is encouraged through group discussion and presentation. We provide tips and techniques for easy learning. We make them practise solving the previous year's university question papers for better performance.

The advanced learners are made the resource persons (mentors) for the slow learners to clarify their doubts with the prior consultation of the subject teacher. PG coaching and coaching for competitive exams will be provided. They are encouraged to give seminars and prepare study projects.

Talented students are identified and trying in their area of interest and are sent to Inter Collegiate & University Level Competitions.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

Response:

Examinations are an important part of any educational institution's academic curriculum. The student's ability, skill, and aptitude can be accessed through examinations. The GDC-Yellandu (affiliated to Kakatiya University) adopts the **Continuous Internal Evaluation System (CIE)**, which is designed by Kakatiya University. According to the system, we can keep track of how the student's educational standards change over time.

Before 2016–2017, there was an annual system for examinations, where the timetable of examinations and question papers were prepared by Kakatiya University. With the implementation of CIE, the institution framed time tables of its own for internal exams and other assessment exams to evaluate the performance of students.

From the academic year 2016-2017 onwards, Kakatiya University implemented CBCS (Choice Based Credit System) based on recommendations from UGC (University Grants Commission). The CBCS aims to improve students' CIE. The examination pattern implemented by Kakatiya University is in the ratio of 80:20, i.e., 80 marks for the semester and examination and 20 marks for internal assessment. For the Science practical examinations, 25 marks were awarded. The following will be used to evaluate how students are graded during internal exams.

- **Student Seminars**
- **Group Discussions**
- **Assignments**
- **Study Projects**
- **Student Regularity and Punctuality**
- **Classroom Interaction**

All departments have WhatsApp groups in which the students and staff are members so that the departments post the required information, such as study materials, college and university circulars, assignments, dates of internal examinations, etc.

After conducting the internal examinations, the performance of students in their subjects will be evaluated by the faculty. If there is any underperformance in any subject, they will be suggested for remedial coaching.

At our institution, some of our faculty members are acting as BoS (Board of Studies) members. They play a substantial role in framing the syllabus or omission of the syllabus; they play a vital role in the introduction of a new syllabus or in question paper design and setting. They look after the suitability of the syllabus to the present scenario in order to fulfil the goals, aspirations, and best wishes of the students.

2.5.2 Mechanism to deal with internal examination related grievances is transparent, time- bound and efficient

Response:

The GDC Yellandu has an examination committee consisting of a convener and members constituted by the principal. The examination branch conducts two internal examinations twice in a semester. The examination coordinator provides all the information relating to the examinations, i.e., all the circulars issued by the universities pertaining to the time schedules for payment of examination fees, the exam timetable, recounting, and revaluation process are circulated to the staff and students from time to time.

Our college is affiliated to Kakatiya University and, therefore, it follows guidelines set by the university for the conduct of examinations. The final exam for each paper has 80% weightage of overall assessment and the remaining 20% constitutes internal assessment marks. The internal assessment is a part of the continuous evaluation system conducted through class tests, assignments, and project presentations. All of these together are part of an internal examination which is carried out in a well planned and systematic manner.

In the Almanac, the internal dates are mentioned. Accordingly, we conduct two internal exams as prescribed by the university. We take an average of two internal exams per month, and every internal exam is conducted for 20 marks. After completion of internal exams, these are uploaded on the university website before final exams.

In general, the college's examination department will help students and solve their problems as quickly as possible, as long as they don't break any rules.

The vision of the institution is to empower female students . The Certificate and add-on courses are designed to fulfil the vision. All the scholars are motivated to complete the course by duly explaining the outcomes of the course and the advantages and opportunities of completion of the course. The outcomes are communicated to the teachers at the very beginning of the commencement of the course within the variety of manuals by the tutorial coordinator/course coordinator, and the same are going to be communicated to the scholars through the teachers concerned in their classrooms. The course outcomes and specific programme outcomes are uploaded within the college website and are available to any or all the stakeholders like teachers, students, and fogeys. The relevance of the course outcomes is discussed by the school and, therefore, feedback is obtained from the scholars. The feedback is analysed and necessary changes are made from time to time.

2.6.2 Attainment of programme outcomes and course outcomes are evaluated by the institution.

Response:

The evaluation process for attainment of programme outcomes and course outcomes is by examination and grade point. There are two types of methods, namely direct and in-direct. These methods are used to assess the core curriculum.

The fulfilment of course outcomes is gauged by observing the performance of the pupil in CIE (Continuous Internal Evaluation) and term-end-examinations of the semester in this method. The pupil's performance is assessed by conducting an internal exam for 20 marks and a semester exam for 80 marks. Their performance is assessed by the total marks gained by them.

The attainment is done by collecting the data from students' alumni in the survey method, where as the fulfilment of programme outcomes and programme specific outcomes is measured by detecting the

performance of the pupil in various competitions like seminars, elocution, student study projects, essays, debates, quizzes, and the preparation of study projects and assignments, etc. Our institution observes both the above processes.

The programme outcomes are also attained by effective planning and implementation of the curricular plan. The award of a degree with obtaining skills is also a major programme outcome. This will be assessed by maintaining and analysing the final result. Our institution keeps records of the results every year.

The other two important parameters to judge whether the Program Outcomes are fulfilled or attained. The placements and getting seats in Higher Education. These activities are looked after by placement cell.

The implementation of certificate courses is also an added advantage to our students. The students were awarded with certificates after implementation.

Due to malnutrition, the students and residents of this area are anemic. We are conducting blood donation camps frequently to create awareness of the importance of donating blood and promote it as a healthy and noble practice.

In this tribal area, the traditional agriculture system is "PODU," in which they cut the trees and clear the forest for farming. After two or three years, they migrate to another area. This causes a lot of erosion and brings down the greenery in this area, leading to ecological imbalance. To prevent this, we are conducting the Haritha Haram program, sponsored by the State Government of Telangana.

4.1 Physical Facilities

4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Response:

Teaching and learning processes can be facilitated effectively only with good infrastructure. The Arts and Commerce streams were started on the day of the inception of the college. Later on in the academic year 2009-10, science courses were also started. The institution has a policy wherein the head of the institution, the teaching and non-teaching staff collectively take decisions.

regarding the fulfilment of the infrastructural needs, The institution sends proposals to CCE for financial assistance and also takes financial support from UGC in the form of additional assistance funds, The college was shifted from the government junior college to the new building on January 23, 2003. The institution started with traditional courses in arts and commerce streams till 2007-08, when two restructured courses were started. Two conventional courses were offered in the science stream in the academic year 2009–10. The institution has been upgrading its infrastructure in tune with the needs of the courses offered. The institution has used the accumulated funds to upgrade the science laboratories. The new building has one floor and one ground floor. The total built-up area is 1534 sq. mts. There are 7 spacious, well-ventilated, and well-furnished rooms in all. There are 7 lecture halls, of which 3 are ordinary class rooms, 3 are equipped with LCD projectors, and 1 is a digital class room. Computer Lab: 01, TSKC Lab-01 (40 computer computer labs), Library: 01, Laboratories: 04 (These laboratories are used for science classes), Games and Sports Office: 01, Gymnasium: 01, Examination Branch: 01, Dr. BR Ambedkar Study Center: 01, Administrative Office: 01 Principal's Chamber 01, Girls' waiting room: 01, store room: 01, Mana TV/TSAT Hall: 01, Girls' Fitness center: 01. There is a playground with volleyball, badminton, kabaddi, and Kho-Kho courts, and sports equipment is available for the students. For the optimum use of the resources in the institution, various committees have been constituted, comprising the Principal as the Chairman, senior members of the faculty as Conveners, other teachers, and some students as members. These committees meet on a regular basis to discuss issues related to their respective committees so as to ensure the optimum use of the facilities on the campus. In order to utilise the facilities to the maximum extent, the students' representatives are nominated as members on each of these committees. The services of the doctors available locally are utilised to create health awareness among students. The in-charge of each faculty (in-charges of the departments, librarian, physical director, etc.) maintains stock and accession registers. These registers are verified annually by the Annual Departmental Verification Committees. These committees are constituted by the members of the faculty related to other departments. There are 7 lecture halls to accommodate classes in the arts, commerce, and mathematics. The four science laboratories are used for teaching and practical purposes for science subjects. The institution has four basic laboratories for science students with the equipment provided by the UGC funds. The computer laboratory satisfies the needs of students who have been admitted to restructured courses. The library, with a reading room, helps as a key resource centre and also provides textbooks and reference books to the students. The TSKC lab is constructed to meet the needs of students enrolled in TSKC. A seminar hall (Room no. 05) has been established to conduct various programmes under co-curricular and extra-curricular activities. The institution has a well-equipped gymnasium and a girls' fitness center.

connectivity. Our institution is currently using B.S.N.L. High-Speed Internet Wired (improvised Wireless) with 60

Mbps Speed. The college is also privileged with Reach Wi-Fi services for use with the students and staff for use with educational purposes when required internet services. The institute has a 24X7 Wi-Fi facility on the college campus for the student and faculty members to avail internet connection at any place on the college campus. Response:

The IQAC developed the pattern for the institution's review system and assessment of learning outcomes. It is divided into two levels: departmental review and institutional review.

The following are some of the ways the institution evaluates its teaching-learning process:

Monitoring of classes: Classes are monitored by the principal, who ensures that classes are held on time and that the academic calendar and almanack are followed.

Feedback from students, teachers, and parents: Students and parents provided feedback on the teaching-learning-evaluation process and the college's development via a structured questionnaire with a rating scale, which was analysed to identify gaps. This is thought to be one of the most effective methods for examining the teaching and learning process and resolving any issues.

Evaluation of Program Outcomes (POs), Program Specific Outcomes (PSOs), and Course Outcomes (COs) Attainment: A method for evaluating the attainment of POs, PSOs, and COs has been designed and implemented. The method ensures the evaluation of the COs vis-à-vis the PSOs at the faculty level, the evaluation of PSOs at the Head of the Department level, and the POs at the principal level. These help in the assessment of the effectiveness of the teaching-learning process.

Reports on Teaching Methodologies: In order to keep an eye on the quality of the teaching-learning process, the IQAC conducted periodic reviews of the teaching methods used by faculty.

Review of Examination Results: Reviewing examination results aids in the evaluation of departments and faculty members in the subjects in question. This allows us to determine whether or not course objectives have been met, and remedial coaching for slow learners can be implemented.

Internal Academic Audit:

The Internal Academic Audit is conducted once a quarter to review academic processes such as curriculum, teaching, learning, evaluation processes, and mechanisms, as well as the adherence of teaching plans to the academic calendar and almanac. It also verifies a variety of teaching and learning methods, including project work, practicals, internal and external assessment.

The Self-Appraisal Form: The Self-Appraisal Form is a widely used tool to improve the quality of teachers. Over the last five years, IQAC has collected API (Self Appraisal Form) from all teaching staff and encouraged and motivated them to improve their performance then and now.

It's used to assess faculty advancement based on a set of criteria.

The CCE conducted an external academic audit by appointing senior and experienced faculty members as Academic Officers.

They verified all academic and development activities across all parameters during their visit and offered suggestions for further improvements in the teaching-learning evaluation process in order to provide quality education. They sent a confidential copy of the academic audit to the CCE.

Our institution is a co-educational college, which can provide all possible facilities and measures for gender sensitization, especially focusing on the safety and security of gentlefolk. The college has installed CCTV cameras, at different focal points to ensure a safe and secure environment for students and staff. The institution regularly organises awareness programmes on the prevention of ragging and other harassment of girl students and women.

Our college also nominates a large number of female students to various programmes to learn the pros and cons of gender sensitisation. The college provides adequate counselling to the students on various gender related issues. The female staff has provided the most care and necessary counselling to the students, particularly those from the most vulnerable sections of society. Our Lady faculty also provide necessary personal counselling and guidance on various socio-economic issues, and they also impart moral and emotional support for the needy girl students.

The college has separate girls' rest rooms with separate washroom facilities. These rooms are spacious and well ventilated. The college has a separate gym facility for boys as well as for girl students to provide exercise, sports and other physical activities. A separate counselling session is initiated for the backward students, especially for the rural and tribal students. To improve their studies, career guidance counselling is also devoted to hunting their talents in various professional activities.
