ORDER:-

The Principal, Govt.Degree College, Chennoor filed requisition for transfer of Govt. land to an extent of (14-07) acres out of S.No.124 PP situated at Kistampet (V) of Chennoor Mandal for construction of Degree College buildings. The Revenue Divisional Officer Mancheria in the reference 2nd cited has reported that the proposals have been processed. No claims and objections were filed on publication of A1 notification. The Gram Panchayat Chennoor also furnished resolution in favour of transfer. The requisitioning Department is a state Govt. on and non-commercial and the land is required for public purpose.

Hence in exercise of the powers conformed in G.O. Ms.No.263 Revenue (P) Department dt.11-3-1970 the Govt. land to an extent of (14-07) acres out of S.No. 124 PP situated at Kistampet (V) of Chennoor Mandal is transferred free of cost in favour of Education Department for construction of Govt.Degree College, Subject to condition that the land should be used for the purpose for which it is transferred and the construction of college building should be completed within one year. Violation of conditions will remove the transfer and the land will be resumed into Govt. custody by Revenue Department without payment of compensation and at any time. The Mandal Revenue Officer chennoor is advised to handover possession of the above land after collecting the sub-Divisional and demorcation charges to the Principal and effect entries in Revenue Records. The Principal is also advised to takeover the possession of the aforesaid land.
