
A meeting was held in the Principal's chamber with the Grievance & Redressal cell members to address the Grievance received from the students.

4. Dr. Sameena Basheer, retired History lecturer will be consulted and invited to give guest lectures and guide the students from examination point of view.





Text books for History v/s are provided in the library and students are instructed to utilize them. Students are advised to consult and ask their doubts online with Dr. Sameena Basheer.



ACTION TAKEN




