

# **MEMORANDUM OF UNDERSTANDING (MOU)**

**Between**

**Department of Chemistry, TTWR Degree & PG College MEN  
Nagarkurnool**

**&**

**Department of Chemistry, SV Government Degree College, Palem  
Nagarkurnool**

This Memorandum of Understanding (herein after referred to as 'MOU') entered on the 12<sup>th</sup> of November 2019, at Jadcherla by and between: **Department of Chemistry, TTWR Degree & PG College MEN Nagarkurnool**, herein after referred as the first party, and **Department of Chemistry, SV Government Degree college, Palem Nagarkurnool** herein after referred to as the Second Party.

The First Party and the Second Party hereby agree as under: **Provision of Academic Facilities/Activities to the students of both parties.**

2. Provision of teaching facilities in needed Topics by the Economics staff of **Department of Chemistry, SV Govt Degree college, Palem, Nagarkurnool.**

**TERMS OF MOU:**

1. **Duration of MOU:** This MOU shall be effective from the date of signing and shall remain in force for a period of 5 years from the said date.
2. **Termination of MOU:** The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Principal, **Department of Chemistry, TTWR Degree & PG College MEN**

**Nagarkurnool**, with a written one month notice to the **Department of Chemistry, SV Govt Degree College, Palem Nagarkurnool** in the event of non-compliance.

3. **FINANCE: Department of Chemistry, SV Govt Degree College, Jadcherla** shall not pay any fees associated with the participation of SV Govt Degree College, Palem Nagarkurnool staff and in the provision of its academic activities.
4. Both parties assure that this agreement does not go against the rules and regulations of **Department of Zoology, TTWR Degree & PG College MEN Nagarkurnool**. (As it is a Government Entity)
5. If this agreement goes against rules & regulations at a later date and when it comes into light, the agreement will stand nullified automatically or will be cancelled immediately by the Principal of **Department of Chemistry, TTWR Degree & PG College MEN Nagarkurnool** or **Department of Chemistry, SV Govt Degree College, Palem, Nagarkurnool**
