## ORDER:-

1. 

As the Government have decided in principle toopen new Government Degree Colleges during 1991-92 the Director of Collegiate Education has he ordinarily submitted this proposal to Government for sanction of a Government Degree College for Women at Wanaparthy, Mahaboobnagar District.
2. In the circumstance statedby the Director of

Collegiate Education in his letter read above, Government hereby sanction for starting of a new Government Degree College for Women at Wanaparthy, Mahaboobnagar District bifurcating the existing Co-education Government Degree College, Wanaparthy into the colleges i.e. Government Degree College for Men and Government Degree College for Women, with one section in BA., with two combinations :-
i) Economics, History and Politics, and
ii) Economics, Public administrationand and Politics, one Section in B.Com., course and one section with B.Sc., with two combinations :-
i) Maths, Physics and Chemistry.
ii) Botany, Zoology and Chemistry.

The Medium of instruction should be in Telugu.
3. The laboratory, accommodation and the furniture in the existing Degree College shall be utilized by both the colleges till alternative arrangements are made for running theGovernment Degree College for women separately. Till such time Government Degree College for Men and Women shall run in shift system. The College for Women may be run in the morning shift.
4. Sanction is also accorded for creation of the following teaching staff for Telugu Medium in respect of Government Degree College for Women at Wanaparthy, Mahaboobnagar District.

The above College shall be accomodated in the existing Government Degree College. The Principal of the Government Degree College may be allowed to receive the applications from the students for admission into Degree Courses till alternative arrangements are made.
7.

The Sanction of the above College for Women shall be subject to the following conditions:-
a) The Sponsor of the Degree College for Women at Wanaparthy, Mahaboobnagar should deposit $1 / 3$ of Corpus Fund of Rs.5.00 lakhs i.e., 1.67 lakhs immediately in the Joint account of the Principal of the College and Regional Director of Higher Education concerned. He should give a bank guarantee immediately for the balance of Rs.3.33 lakhs. The sponsor should deposit the balance of Rs. 3.33 lakhs in two instalments i.e., Rs. 1.67 lakhs into the joint account during the beginning of the second year of the course 1992-93 and the rest ofRs.1.66lakhs into the joint account during the beginning of the third year of the course 1993-94 failing which the bank guarantee will be encashed.
b) The sponsor should also provide land of $2 / 4$ acres if the student's strength is upto one thousand and above one thousand, respectively as envisaged in G.O.Ms.No.1623, Education, dated : 12-10-90.
c) A good building with furniture should be provided by the sponsor without any financial commitment to Government until permanent buildings are constructed by the Government.
8. The Corpus fund shall be deposited in the joint account of the Regional Joint Director Higher Education concerned and the Principal of Local Government Degree College for the present till regular Principal of Government Degree college for Women joins duty. Afterwards the Joint Account may be transferred in name of the Regional Joint Director Higher Education concerned and the Principal of Government Degree College for Women concerned.
9. The staff sanctioned above will draw the usual scales of pay and allowances as admissible under rules in force from time to time.
10. The Director of Collegiate Education is requested to see that wherever possible to the surplus posts in the area or those appointed in supernumerary posts shall be absorbed in these new posts.
11. The University concerned of the sanctioned college is requested to extend the time limit for registration of applications from the students and also for their admission into the college during 1991-92.
12. Sanction is accorded to incur expenditure of Rs.8.92 Lakhs ( Rupees Eight lakhs ninety two thousand only),
(Rs.8.42lakhs towards salaries and Rs.50,000/- towards office expenses)for Government Degree College for Women, Wanaparthy, Mahaboobnagar district.
13. As there is no Provision available in the budget, the expenditure sanctioned in Para 12 above shall be incurred in
relaxation of treasury control order and debited to the head of account "2202 - General Education -03 - University and Higher Education - M.H. 103 -Government Colleges and insti-tutes- Schemes included in the Plan - S.H.(08) Govt. Degree College for Women" (Plan) as detailed below -
