 - The institution is affiliated to Osmania University, Telangana, Hyderabad. The syllabi and regulations are totally adopted from the parent university.

However, various extension lecturers/guest lectures are arranged from time to time for wider exposure to latest knowledge and skills. Several workshops were organized for the students in different disciplines Viz., English, Commerce, Hindi, Telugu etc. Innovative methods are implemented in the classroom to make the teaching-learning process more effective. The students are taken on field trips to reputed institutes. They are further encouraged to participate in various innovative programmes conducted by Commissionerate of Collegiate Education, Telangana. Several students have taken up project works and have won prizes in the District/State level competitions (JIGNASA). Orientation programmes on personality development and career counselling are arranged periodically. Few meritorious students are identified in each section and are given coaching for various PG entrance examinations of National universities. Funds have been mobilised from few philanthropists in order to develop the infrastructure facilities of the institution and upgrade the teaching facilities viz., installation of LCD projectors, digital boards, furniture etc.

Best Practicel Title of the Activity: Scholarships for meritorious students by Mahindra Finance Goal: To motivate the economical weak, meritorious students to achieve new heights The Context: Mahindra Finance is leading company offering financial services to many parts of our country. As a CSR initiative, they annually award scholarships to the meritorious students from economically weaker sections. The Practice: The final year students were eligible for the scholarship. They were trained in the interview skills by the Telangana Skills and Knowledge centre of the College. A screening test was conducted followed by interview of the shortlisted candidates by a selection committee. Evidence of Success: Around 21 students were selected for the merit scholarship. An amount of Rs.10,000/ each was given to the students. Best Practice2 Title of the Activity: Midday meals to facilitate Intensive Examination Preparatory programme (IEPP) Goal: To facilitate examinationoriented preparation of the students under the guidance of the teachers by retaining them in the college for longer duration. The Context: The students of the institution often skip the study hours, as they do not bring lunch, sometimes the hostels do not pack and provide them lunch and various other such reasons. The Principal and the teaching staff have deliberated and arrived at the conclusion to provide midday meals for 40 days to facilitate them to prepare for the endsemester examinations by staying in the college for longer duration. The Practice: The institution has mobilized funds from the philanthropists and has collaborated with the Äkshaya Patra foundation to provide fresh, healthy meals to the students at a subsidized price (expenditure borne by the college). The programme went on uninterruptedly for 45 days. The students were provided with good food every day afternoon. Evidence of Success: There was a good improvement in the strength during the study hours. Many students were benefited by the scheme.
