- ii) Botany, Zoology and Chemistry.

A large number of temporary posts are being continued year after year without detailed scrutiny of their necessity or relevance and it has been felt that the Staff Continuation proposals should be considered only after critically examining as to what minimum staff is required to be continued with reference to the balance work to be done during the year in future.

2. To examine the proposals of the further continuation of temporary posts based on the above guidelines, Government hereby constitute Implementation Committees with the following composition:

3. However, if the proposals relate to continuation of posts in the Departments of Secretariat, the concerned circulating officer incharge of establishment will be the convener.

4. The concerned Department should send the proposals in the prescribed forms as has been appended and based on the information given by the concerned department. The above Implementation Committee should give its recommendations as to which of the proposed posts should be continued for what period in the year and as to which of the posts should be made permanent.

5. Pending recommendations of the Implementation Committee, all the temporary posts which were continued till 23-2-1995, shall be continued further upto 30-9-1995 if considered necessary by the concerned Department.
