Copy of the Government order read above is communicated.

Government have sanctioned the opening of new Govt. Degree College at Chinnoor in Adilabad Dist. The College shall start with one section each in 1st year B.A. and B.Com. courses and one of the three optional subjects shall be a restructured course, as approved by the University.

The medium of instruction should be Telugu, English medium can also be opened provided there is a minimum strength of 30 students in the course concerned and with the prior permission of the Govt.

The Principal, Govt. Junior College, Chinnoor is requested to issue notification inviting applications from the eligible students for admission into 1st year B.A. and B.Com. courses immediately and make admissions by following the rules of admission now in force to newly sanctioned Govt. Degree College, Chinnoor, pending posting of regular Principal to this college.

The admissions should be made strictly in accordance with rules now in force for the intake as prescribed by the Universities concerned and completed before 10-8-1984. No extension of time for admissions will be given. The Principal is requested to send a detailed report on the admissions made for the B.A. and B.Com. course in the college promptly to the DHE under intimation to the Universities concerned.

Pending posting of regular staff, the Principal of Govt. Junior College, Chinnoor is requested to make part time arrangements of teaching staff on the basis of "offer of remuneration" for giving lecturers on hourly basis. He is further informed that no regular appointment orders should be given to the Part-time appointments. It should be made clear that the persons who are engaged to do part time teaching work will be paid remuneration only on hourly basis @ Rs.10/- per hour. The proforma of engaging persons for during part time work should be as follow.
