SUB: Scrutiny of UGC records – Certain observations

The University Grant commission sanction funds for the purchase of books and journals, equipment and repairs and maintenance of buildings under various scheme of development and college activities under the graduate program during plans XI & XII under certain

i) The grant is subject to the adjustment on the bases of utilization certificate (UC) in prescribed Proforma submitted by the college .II) Expenditure should be made on approval items.III) If such grants utilized for any other purpose without permission of UGC, such college sead to function and assets remit to the UGC etcs

During the scrutiny of UGC records the following short comings were noticed;

1) An amount of Rs 1159948 released by the UGC for purchase of books and journals/equipments and the same were utilized by the college principal. However, no purchase invoices were forthcoming in the records made available to audit. The same may be produced to audit for scrutiny .As details below.

- 2) An amount of Rs 68000 purchases were made and cheques were issued for material suppliers vide cheques nos 015539 25-3-12 and 015540/25-3-12). However, no purchase 29-05-invoices were forthcoming in the records made available to audit. The same may be produced to audit for scrutiny.
- 3) Improper purchase of books and journals/equipments

As per APFC Vol.I – Rules and instructions governing the purchase of Stores – Rule III 7 under Article 125 of APFC Vol-I, the Finance Dept. Govt. of A.P. issued G.O. M.S. No. 258, dt. 20.09.2013 directing all the departments that materials/stores costing more than Rs.1.00 lakh shall be procured through e-procurement platform only. However, the college principal purchases were made an amount of Rs 832073/-directly from suppliers (Material supplied contract) without calling inviting tenders and without giving paper ads. Which is against to the provisions. The reasons for non-following of procedures before procurement of Materials may be finished to audit. As details below.

1	During the Audit we observed that GDC-Badrachalam not updating CAIMS on regularly basis.	It is recommended that management has to update CAIMS on regular basis to avoid errors and for easy closure of books of accounts.			
2	During the Audit we observed that GDC-Badrachalam not maintaining any separate register for Fixed assets.	The main purpose of a fixed asset register is to keep track of the book value of the assets and determine depreciation to be calculated and recorded for management and taxation purposes. So we suggested the management to maintain Fixed assets register.			
3	During the Audit we observed that they are not maintainig proper cash book which means they are simply preparing cash book by copying same as bank statement and they are updating the CAIMS cash book as per bank statement.	The purpose of Cash book is to manage cash efficiently, making it easy to determine cash/bank balances at any point in time. It helps to identify transactions like cheques issued but not debited in bank and to know exact cash book balance as on date. So we suggested the management to maintain cash book by updating with day to day transactions.			
4	During the Audit we observed that GDC - Badrachalam not updating Cash Book for the Exam Branch A/c.	It is recommended that management to update Cash Book on regular basis.			
5	During the Audit we observed that they are not preparing Bank reconciliation statement on monthly basis.	BRS is prepared on a periodical basis for checking that bank related transactions are recorded properly in Cash book. BRS helps to detect errors in recording transactions and determining the exact bank balance as on a specified date. So we suggested the management to make BRS on monthly basis to know that exact balance as on date.
