PREAMBLE

 - d) Conducting International Conferences/Seminars in the areas of, chemistry, life sciences, Biochemistry Biotechnology, etc.
3. Financial & patent issues
 - a) Patents will be shared by both parties

The parties may with the written consent of the other party, such consent not be unreasonably withheld, publish the findings of the cooperative activities of the parties in the form of an article in a journal, newspaper, or other magazines. A copy of the article shall be provided before publication to the party whose written consent is required hereunder for that party's perusal and written consent.

Amendments:

This MOU may be amended only by written consent of the parties, Annexures may be amended, or supplemented at any time, through the mutual written consent of the parties.

Liability

Unless otherwise regulated in this MOU or separate agreements based on this MOU, the parties are only liable to one another for wilful acts and gross negligence. Claims for damage of any nature whatsoever will be limited to direct damages only.

JOINT RESPONSIBILITIES

Both parties shall not disclose confidential information and intellectual properties, projects, process, and patents to any third party. Any legal implications will be confined to Hyderabad Jurisdiction only.

This MOU shall be valid for five years from this date and can be renewed for a further period of three years upon mutual consent.



