Commissionerate of Collegiate Education Telangana has conducted review meetings with Principals, Academic Coordinators & IQAC Coordinators of certain Government Degree Colleges to review the academic and administrative issues on 02.11.2019, 20.11.2019, 21.11.2019 & 25.11.2019. During these meetings it has come to the notice of CCE that Government Degree Colleges are maintaining different Bank Accounts. Maintenance of cashbooks for all these accounts is hampering the work in office due to dearth of non-teaching staff. In this connection CCE has instructed for maintaining only One Bank Account per college for general purpose (Other than specific schemes) transparency.

Hence all the Principals of Government Degree Colleges in Telangana State are instructed to maintain only the following accounts from 01.12.2019. Principals are instructed to transfer the amounts of any other bank accounts to Vijaya Bank (now Bank of Baroda) Account with which the department has signed a MoA on 27.03.2019. Hence the account shall be the Official College Account.

If any other bank accounts other than above mentioned accounts are to be found, disciplinary action will be initiated accordingly.

The details of accounts (Cash Book) shall be maintained in College Administration & Information Management Systems (**CAIMS**) without fail with opening balance from the date of 01.04.2019.
