All the Principals of Identified Degree Colleges/ Principals of Government Degree Colleges in the State are hereby informed that Govt. have taken various measures to expedite disposal of Pension Cases and to remove bottleneck in the settlement of pension cases. Government have also been considered to remove any intermediate authority by which means the Pension Papers could be moved to Accountant General (A&E) authority directly and to see that a retiring Government Servant shall get his Pension on the date on which he would have received his salary but his retirement. Accordingly Government has decided to delegate the Powers to sanction pension (pension sanctioning authority) in respect of Gazette officers in various departments (other than Secretariat Department) to Head of the Department only.

Accordingly, all the Principals of Identified Degree Colleges/ Principals of Government Degree Colleges in the State are directed to send the pension proposals of Administrative Officers working in the state to the Commissioner of Collegiate Education six months before the known date of retirement and ensure to get the pensionary benefits in time without any delay.
