- Sub: Collegiate Education Delegation of powers to the Commissioner of Collegiate Education, T.S., Hyderabad, for the distribution of the sanctioned strength in the categories of Degree Lecturers, Physical Directors and Librarians among the Government Degree Colleges as per the requirement – Regarding.

In the G.O 2<sup>nd</sup> cited, the Government in Finance (HRM-I) Department, has issued orders for the creation of 1384 posts in 115 Government Degree Colleges (374 posts in 58 Government Degree Colleges started before 2008 and 1010 posts in 57 Government Degree Colleges started after 2008). Further, the Finance (HRM-I) Dept. in the said G.O., has requested to issue College wise and subject wise distribution statement for the above sanctioned posts.

2. In the references 4<sup>th</sup> and 5<sup>th</sup> cited, the Commissioner of Collegiate Education, Telangana State, Hyderabad has stated that in G.O 3<sup>rd</sup> cited, the Government has constituted a Committee to examine and approve the reorganization of the courses/intake strength of the courses in Government Degree Colleges. Further, the Commissioner of Collegiate Education, T.S., Hyderabad, has stated that in G.O 1<sup>st</sup> cited, the Government have delegated powers to the Commissioner of Collegiate Education, to convert/ transfer surplus teaching posts in Government Degree Colleges in the State and therefore in continuation of the G.O 1<sup>st</sup> cited, the CCE has requested the Government as follows:-

- i. to extend the delegation of powers to the Commissioner of Collegiate Education for the distribution of Lecturer posts including the (1214) posts sanctioned in the G.O 2<sup>nd</sup> cited, to the needy Government Degree Colleges in the State, based on the re-organization of the courses and workload in the respective subjects in the Colleges and also accordingly,
- ii. to extend the delegation of powers to the Commissioner of Collegiate Education for distribution of the posts of Physical Directors and Librarians, including the (131) posts (i.e., 67 PDs and 64 Librarians) sanctioned in the G.O 2<sup>nd</sup> cited, to the needy Government Degree Colleges in the State.

**3.** After careful examination of the matter, the Government hereby delegate the powers to the Commissioner of Collegiate Education, Telangana State, Hyderabad, for the distribution of the existing sanctioned strength and the sanctioned strength as per the G.O 2<sup>nd</sup> cited, in the categories of Degree Lecturers, Physical Directors and Librarians among the Government Degree Colleges, as per the requirement, based on the reorganisation of the courses by the Committee constituted vide reference 3<sup>rd</sup> cited.

In pursuance of the orders issued vide G.O in the reference 1<sup>st</sup> read above, a committee has constituted for Reorganization of Courses in Government Degree Colleges in the State. And accordingly the Collegiate Education Department has examined with reference of the demand of the Courses, work load and Student Strength in certain Government Degree Colleges for the Academic Year 2021-22.

In this regard, the Commissioner of Collegiate Education has identified an imbalance in the teaching faculty in the Colleges based on the workload calculation. In view of this, certain surplus teaching faculty along with posts shifted based on the workload calculation and reorganization of posts of regular teaching staff under administrative grounds.

Hence, in exercise of powers given in the reference 2<sup>nd</sup> read above, the Commissioner of Collegiate Education has accorded permission to shift certain teaching faculty along with post to needy GDCS in certain Government Degree Colleges in the state

In view of the above circumstances, it is to state that as per reference 1<sup>st</sup> and 2<sup>nd</sup> cited above, the Collegiate Education Department has shifted certain surplus teaching faculty along with posts based on the workload calculation and reorganization of posts of regular teaching staff under administrative grounds.

Hence, the Director of treasuries and Accounts is requested to permit for claiming of the salary of the Teaching Faculty of Government Degree Colleges in the state by the District Treasury Offices of concerned Districts at an early date.
