Steps to complete the examination Fee payment & Submission of EAF as follows

STEP 01 **COLLECT**

Collect Examination Application Form (EAF) From Exam Branch(Autonomous) before due date.

STEP 02 **FILL**

Fill the EAF and Pay the Examination fee as per fee schedule through **OCTOPOD** before due date.

STEP 03 **ATTACH**

Attach all the required certificates(Exam Fee paid receipt) to EAF

STEP 04 **SUBMIT**

Submit filled EAF along with Fee paid receipt to the Exam Branch(A) before due date.

Instructions to the students:

1. All the first year students appearing for II Semester regular exams (to be held from **21st May 2024**) for the Academic Year 2023-24 are here by informed to pay this exam fee on or before **08-04-2024** without fine and with fine of Rs.200/- up to **15-04-2024** & with fine of Rs. 500/- up to **18-04-2024**.
2. The Examination fee once paid by the candidate will not be refunded or adjusted.
3. No exam fee will be collected from Visually Challenged, differently abled, hearing-impaired Blind, Physically Disabled, Deaf & Dumb students as per Government Orders. A copy of Medical Certificate confirming their status of disability. (Minimum percentage of disability must be of 40%) must be attached to the Application forms.
4. The payment of examination fee & Submission of application forms **will not be entertained after the due date** under any circumstances.
5. The Examination application forms of the candidates will be accepted who have put in required percentage of attendance (Minimum of 75%).
6. Students can collect the Examination application forms (EAF) from the college exam branch (Autonomous) and submit duly signed EAF to the examination branch along with the fee paid receipt and Xerox copies of the memorandum of marks of earlier Examinations to verify eligibility.
7. Examination fee will be collected only from those who were paid Admission fee for 2023-24 Academic year.
8. Students can pay exam fee through Octopod Link which provided in college website/octopod website.
