## MEMORANDUM OF UNDERSTANDING (MOU) between Department of Political Science, Dr. BRR Government Degree College and Vision Through Ears (NGO), Hindupur, Anantapur.

This Memorandum of Understanding (herein after referred to as 'MOU') entered on the 22<sup>nd</sup> of JULY 2018 at Jadcherla by and between: Department of Political Science, Dr. B.R.R. Government Degree College, Jadcherla, Mahabubnagar District of Telangana herein after referred as the first party, Vision Through Ears (NGO), Hindupur, Anantapur District of Andhra Pradesh herein after referred to as the Second Party.

The First Party and the Second Party hereby agree as under:

Provision of study material in accessible format to the visually challenged students of Dr. B.R.R. Government Degree College, Jadcherla by Vision Through Ears and preparation of different books in accessible format for visually challenged persons in Two Telugu states by staff and students of Dr. BRR Government Degree college, Jadcherla. (Content of MOU should be mentioned here)

## **Objectives:**

- 1. Provision of study material in accessible format for the visually challenged students in Dr. B.R.R Government Degree College, Jadcherla by Vision Through Ears.
- 2. Preparation of various books in accessible format by staff and students of Dr. BRR Government Degree to enrich the accessible books for the visually challenged persons in Two Telugu states.

## **TERMS OF MOU:**

- 1. **Duration of MOU**: This MOU shall be effective from the date of signing and shall remain in force for a period of 4 years from the said date.
- 2. Termination of MOU: The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Principal, Dr. B.R.R. Government Degree College, Jadcherla with a written one month notice to the Director Vision Through Ears, Hindupur in the event of noncompliance.

- FINANCE: neither Dr. B.R.R. Government Degree College, Jadcherla nor Vision Through Ear, Hindupur pay any fees in preparation and exchange of accessible books related to visually challenged persons.
- 4. Both parties assure that this agreement does not go against the rules and regulations of Dr. B.R.R. Government College, Jadcherla. (As it is a Government Entity)
- 5. If this agreement goes against rules & regulations at a later date and when it comes into light, the agreement will stand nullified automatically or will be cancelled immediately by the Principal of Dr. B.R.R. Government Degree College, Jadcherla or Director, Vision Through Ears, Hindupur.
