MEMORANDUM OF UNDERSTANDING (MOU) Between Dr. B.R.R.Government Degree College And Grailmaker Innovations Private Limited

This Memorandum of Understanding (herein after referred to as 'MOU') entered on the 07 Day of MARCH 2022 at Jadcherla by and between: Department of Political Science, Dr. B.R.R.Government Degree College, Jadcherla, MAHABUBNAGAR accredited with NAAC "B" grade, herein after referred as the First Party, and GRAILMAKER INNOVATIONS PRIVATE LIMITED, a Company incorporated under the provisions of the Companies Act, 2013 having its registered office at Hyderabad, herein after referred to as the Second Party.

The First Party and the Second Party hereby agree as under:

Making the campus of B.R.R.Government Degree College, Jadcherla, accessible for persons with Visual Impairment through 'Spacefelt labels', a novel smartphone-based Assistive Technology solution developed by Grailmaker Innovations.

Objectives:

- Installing 'Spacefelt labels' at selected places and facilities within the campus of Dr. B.R.R.
 Government Degree College and recording audio descriptions into those labels, so that they can be later accessed using the 'Spacefelt Smartphone App'.
- 2. Training selected students and staff of Dr. BRR Govt. Degree College on the installation, recording, reading, and maintenance of the labels.
- 3. Provision of labels, App, and technological support by Grailmaker Innovations.

TERMS OF MOU:

- 1. **Duration of MOU**: This MOU shall be effective from the date of signing and shall remain in force for a period of 2 years from the said date.
- 2. Termination of MOU: The partnership covered by this MOU shall terminate on completion of the stipulated period.

3. Deliverables: The Second Party shall provide the First Party the Spacefelt smartphone App and 108 (One Hundred and Eight) 'Spacefelt public labels' in physical and digital formats, and provide technological support for the duration of this MOU. The First Party shall take full responsibility of installing, recording, and maintaining the labels, and providing usage instructions to the visitors and beneficiaries in their campus.

4. Finance: The First Party shall pay Rs 10,000/- (Rupees Ten Thousand Only), inclusive of all taxes, to the Second Party for the deliverables mentioned in this MOU. The terms & conditions of the

payment shall be mentioned in the invoice provided by the Second Party.

5. Technology and IP: The Second Party is NOT granting the First party any rights to any intellectual property supporting all of part of the deliverables, including the labels and the Application, and the First Party makes no claim to ownership of these deliverables or any intellectual property that

it may contain.

6. Limitation of liability: The Second Party will not in any case be held liable for damages caused to

the users or visitors or the labels because of incorrect recordings or maintenance by the First Party.

However, the Second Party grants the First Party the right to make physical copies of the labels

provided in the digital format and replace the damaged labels, provided the name 'spacefelt.com'

is mentioned legibility in the labels.

7. If this agreement goes against the Terms & Conditions of either parties at a later date and

when it comes into light, the agreement will stand nullified automatically or will be cancelled

immediately by the Principal of the First Party or the Directors of the Second Party.
